Patient Safety - the task before all healthcare providers

Patient safety is now recognized as a serious global public health issue. Every point in the process of caregiving contains a certain degree of inherent unsafety. Estimates show that in developed countries as many as one in 10 patients is harmed while receiving hospital care, in developing countries, the probability is higher.

Industries with a perceived higher risk such as aviation and nuclear plants have a much better safety record than health care. There is a one in 1, 000, 000 chance of a traveller being harmed while in an aircraft. In comparison, there is a one in 300 chance of a patient being harmed during health care. And the potential to harm can go to the extent of endangering patient lives.

Approximately 80 percent of medical errors are system-derived. Good people simply working harder will be insufficient to overcome the complexities inherent in today's systems of care to prevent errors and harm to patients. Errors will occur; the key is to design the care delivery systems so that harm does not reach the patient.

Patient safety improvements demand a system-wide effort, involving a wide range of actions covering infection control, safe use of medicines, equipment safety, safe clinical practice and safe environment of care.

It is therefore important that patient safety encompasses the concept of "reliability." It involves human lives. "Safety shows itself only by the events that do not happen". Deaths and harm from medical errors are not inevitable but preventable. All healthcare organizations today must have this clarity of the task before us and commit to rolling up their sleeves and making it a reality.
